NOTICE OF ANNUAL GENERAL MEETING FOR 2016

1 INTRODUCTION

I am pleased to be writing to you with details of our annual general meeting (“**AGM**”) which we are holding at the offices of Hill Dickinson LLP, The Broadgate Tower, 8th Floor, 20 Primrose Street, London, EC2A 2EW at 4p.m. on 9 October 2017 (London time). The formal notice of AGM is set out at the end of this document.

The purpose of this circular is to provide you with an explanation of the resolutions to be proposed at the AGM and of the action you should take in order to register your vote.

2 AGENDA OF ANNUAL GENERAL MEETING

The following resolutions are to be proposed at the

AGM: **Ordinary Business**

Resolution 1 – Receiving and adopting the Accounts

The Board recommends the receiving and adopting of the audited accounts for the financial period ended 31 December 2015 together with the Report of the Directors’ and the Auditors’ Report.

Resolution 2 – Auditors’ Reappointment and Remuneration

This Resolution relates to the re-appointment of Chapman Davis LLP as auditors of the Company and authorises the Directors to determine their remuneration.

Resolution 3 – Re-election Anthony Samaha

The Board recommends the re-election of Anthony John Samaha who was appointed to the Board on 28 April 2016 following the last Annual General Meeting of the Company and who is subject to re-election in accordance with the Company’s Articles. Mr Samaha, being eligible, offers himself for re-election as a Director of the Company.

Mr Samaha is a Chartered Accountant with over 20 years’ experience in accounting and corporate finance. Mr Samaha worked for over 10 years with international accounting firms, including Ernst & Young, principally in corporate finance, gaining significant experience in valuations, IPOs, independent expert reports, and mergers and acquisitions.

Resolution 4 - Re-election of David Lenigas

The Board recommends the re-election of David Lenigas who was appointed as Executive Chairman on 30 June 2016 following the last Annual General Meeting of the Company and who is subject to re-election in accordance with the Company's Articles. Mr Lenigas, being eligible, offers himself for re-election as a Director of the Company.

Mr Lenigas holds a Bachelor of Applied Science Degree in Mining Engineering (Distinction). He has served as Executive Chairman of numerous public listed companies on the London, Canadian and Australian Stock Exchanges.

Special Business

Resolution 5 - Disapplication of Pre-Emption Rights

Shareholders' approval is being sought for the authority of the Directors to allot new ordinary shares on a non pre-emptive basis, and to grant rights to subscribe for new ordinary shares, for cash up to the entire unissued ordinary share capital of the Company, such authority to expire at the conclusion of the next annual general meeting of the Company or 15 months from the date of passing of the resolution, whichever is the earlier. This will allow the Board to allot shares without recourse to the shareholders so that it can move quickly from time to time as it deems appropriate. If granted, the authority would only be exercised if the Directors believed that to do so would be in the best interests of the shareholders as a whole.

3 ACTION TO BE TAKEN

A Form of Proxy is enclosed for use in connection with the AGM. Whether or not you intend to be present at the AGM, you are requested to complete, sign and return the Form of Proxy to the Company at Suite 3B, Princes House, 38 Jermyn Street, London, SW1Y 6DN, as soon as possible but in any event so as to arrive not later than 4p.m. on 6 October 2017. The completion and return of a Form of Proxy will not preclude you from attending the meeting, or speaking and voting in person should you subsequently wish to do so.

4 RECOMMENDATION

The Directors consider that the passing of the resolutions would be in the best interests of the Company and of the Shareholders and therefore unanimously recommend Shareholders to vote in favour of the resolutions, as they intend to do or procure to be done in respect of their own legal and beneficial shareholdings, which in aggregate amount to 204,000,000 ordinary shares, representing approximately 13.97 per cent. of the issued ordinary share capital of the Company.

SPECIAL RESOLUTION

5.
